STATUTE GOVERNING THE POWERS & WITHDRAWAL DEGREE/DIPLOMA AS PER SECTION 40(1)(e) OF K.S.U. ACT 2000.

1. TITLE & COMMENCEMENT :

- i) This Statute called as the statute governing the powers withdrawal of Degree/Diploma.
- ii) This Statute shall come into force from the date of assent of H.E. the Chancellor.

2. APPLICATION :

This statute shall apply to all or any of the candidate having awarded Degree/Diploma of this University.

3. DEFINITION :

- i) "Degree" means any degree conferred by the University on any Convocation.
- ii) "Diploma" means any diploma awarded by the University or any occasion may attached to the P.G. Course or separate awarded of
- iii) "Withdrawal" of Degree/Diploma means annulling the conferred degree or diploma

4. WITHDRAWAL OF DEGREE OR DIPLOMA CONFERRED UNDER PROVISIONS OF SECTION 70 OF K.S.U. ACT 2000.

- I) The Syndicate may on recommendation of the Academic Council withdraw any distinction , degree, diploma or privilege conferred on or granted to, any person by a resolution passed by a majority of the total members of the Syndicate and by a majority of not less than two thirds of the members present and voting at the meeting, if such a person has been found to have obtained such a degree of diploma or certificate fraudulently or has obtained admission through a false caste certificate.
- II) The Syndicate may on the recommendation of the Academic Council withdraw any distinction, degree diploma or privilege conferred on or granted to any person, by a resolution passed by a majority of the total membership to the Syndicate and by a majority of not less than two-thirds of the members of the Syndicate present for voting at the meeting, if such person has been found convicted by a court of law or an offence which, in the opinion of the Syndicate involves moral turpitude or if he has been guilty of misconduct.
- III) No action under this section shall be taken against any person unless he has been given an opportunity to show cause against the action proposed to be taken.
- IV) A copy of the resolution passed by the Syndicate shall be immediately sent to the person concerned.
- V) Any person aggrieved by the decision taken by the Syndicate may appeal to the Chancellor within thirty days from the date of receipt of such resolution.
- VI) The decision of the Chancellor on such appeal shall be final.

5. JUSTIFICATION :

To incorporate the above statute it may be stated that section 40 (1) (e) of KSU act 2000, provides a proviso to frame the above statutes and section 70 of K.S.U. Act 2000 is also conferred the powers to the Syndicate on the recommendation of the Academic Council to withdrawal or annual the conferred degree/diploma.

6. REPEAL & SAVINGS OF STATUTES :

The Karnataka University's statutes made under any previous Acts are hereby repealed. Notwithstanding such repeal anything done or any action taken under the principal act as amended by the such ordinances shall be deemed to have been done or taken under the principal Act as amended by this Act.

Draft Statute Governing the conferring of Honorary Doctorate Degrees during Annual Convocation.

PREAMBLE :

The process of conferring Honorary Degree is being governed by the existing Statute titled “Statute Governing Convocations for conferring Degrees and Diplomas (Framed under section 40 (d) and to award Honorary Degree under section 69 read with section 68 and 40 (1) (c) of the KSU Act 2000)”. In the meanwhile Hon’ble Governor & Chancellor of the Universities has directed the University to modify the draft statute according to the guidelines of the circular no GS 02 GUM 2016 dated 18.02.2016. Hence, the following statute :

STATUTE :

1. Title and Commencement :

- i. This Statute shall be called “Statute Governing the conferment of Honorary Doctorate Degrees under section 40(1) c and Section 69 sub-sections (1), (2), (3) and (4) of the KSU Act 2000”.
- ii. This Statute shall come into effect from the date of assent to it by H.E. the Chancellor.

2. Eligibility for Convergence of Honorary Degrees :

- i. The Honorary Degree of Doctor of Literature (D.Litt.) Honoris Causa may be conferred, only upon those persons who have substantially contributed to the advancement of Literature, Philosophy, Arts, Music, Painting or any other subject as assigned to Faculties of different Disciplines of study.
- ii. The Honorary Degree of Doctor of Science (D.Sc.) Honoris Causa May be conferred, only upon such persons in the branch of Science or Technology, Planning, Organizing or Developing, Scientific and Technological Institutions, who have substantially contributed to the cause of Science.
- iii. The Honorary Degree of Doctor of Laws (LL.D.) Honoris Causa may be conferred, only upon those persons who have to be distinguished Lawyers, Judges or Juries and Statesmen.

3. Time of Conferment :

- i. The Honorary Degree shall be conferred at the Annual Convocation to be held by the University once in a year or at such other times as the H.E. the Chancellor may direct the University.
- ii. The presentation of persons(s) at the Convocation on whom Honorary Degrees (s) are to be conferred shall be made by the Vice-Chancellor.

4. Process of recommendation :

- i. The University Syndicate shall properly consider and deliberate on all the applications/proposals received for the award of Honorary Doctorates.
- ii. After the deliberations the Syndicate will recommend the names by a majority of not less than two-thirds of its members present.
- iii. The University shall forward such names to the Scrutinizing Committee at least 45 days in advance to the date of Convocation.
- iv. The University shall nominate its nominee to the Scrutinizing Committee well in advance.

5. Confidentiality :

The names recommended by the University Syndicate shall be kept confidential and under no circumstances be disclosed to anybody or to the press till the approval of the H.E. the Chancellor is received.

6. Repeal and Savings :

The existing statute titled Statute Governing Convocations for Conferring Degrees and Diplomas (Framed under section 40 (d) and to award Honorary Degree under Section 69 read with section 68 and 40 (1) (C) of the KSU Act 2000) is hereby repealed.

Statute:

S.1 :

The University may in the exercise of its powers under section 25 sub-section (2) (g) of K.S.U. act, 1976, to prescribe charge and collect fees for tuition, research, admission to examination and convocations, services undertaken by the University, affiliation and inspection of colleges and registration of graduate and such other purposes as detailed below in supersession of existing ordinances, regulation etc. with effect from 1998-1999 onwards.

S.2 The University shall collect the registration fees called as 'Karnataka University Registration Fees' as under.

- a) Rs.50/- for General Merit candidates and Rs.25/- for SC/ST and Category-1 students for non-professional**
- b) Rs.250/- for General Merit candidates and Rs.125/- for SC/ST and Category-1 students for the Engineering and Meical Faculty from those students who are admitted prior to 1996 under Karnatak University.**

S.3 The University may enhance the Examination fees, the Affiliation fees and other fees by 10% every two years.
